2. Exit 226B to merge onto I-40 West toward Gallup/Grants
3. Exit 22 toward Miyamura Dr/Montoya Blvd
4. Turn right at Ford Dr/Mivamora Opas
5. Take the 1st left onto Joseph M Montoya Blvd and continue straight onto W Maloney Ave
6. Turn left at North 3rd St
7. Turn left at West Hill Ave

The McKinley County Courthouse is located at 207 West Hill St in Gallup, NM 87301.

From Las Cruces:

1. Take I-25 North toward Albuquerque
2. Exit 203 for NM-6 toward Los Lunas
3. Turn left at NM-6 W/Main St SW and continue to follow NM-6 West
4. Turn left to merge onto I-40 W toward Gallup/Grants
5. Exit 22 toward Miyamura Dr/Montoya Blvd
6. Turn right at Ford Dr/Mivamora Opas
7. Take the 1st left onto Joseph M Montoya Blvd and continue straight onto W Maloney Ave
8. Turn left at North 3rd St
9. Turn left at W Hill Ave
