B. The commission [shall have] has concurrent jurisdiction and authority with the <u>oil conservation</u> division to the extent necessary for the commission to perform its duties as required by law. In addition, any hearing on any matter may be held before the commission if the division director, in [his] the director's discretion, determines that the commission shall hear the matter."
