AN ACT

RELATING TO CONGRESSIONAL REDISTRICTING; ESTABLISHING  
CONGRESSIONAL DISTRICTS FOR THE ELECTION OF REPRESENTATIVES TO  
THE UNITED STATES CONGRESS; CHANGING PROVISIONS OF THE ELECTION  
CODE RELATING TO PRECINCTS; AMENDING, REPEALING AND ENACTING  
SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**SECTION 1.** Section 1-15-15 NMSA 1978 (being Laws 1969,  
Chapter 240, Section 365, as amended) is amended to read:

"1-15-15. UNITED STATES REPRESENTATIVE--CONGRESSIONAL  
DISTRICTS ESTABLISHED.--New Mexico is divided into three  
congressional districts to be known and designated as  
congressional district [~~number~~] one, congressional district  
[~~number~~] two and congressional district [~~number~~] three."

**SECTION 2.** Section 1-15-16 NMSA 1978 (being Laws 1991

5 A. Congressional district one is composed of  
6 Bernalillo county precincts 1 through 30, 32 through 99, 101

8 161 through 166, 170, 171, 180 through 187, 191 through 197,  
9 211, 212, 214 through 217, 221, 223 through 226, 241 through  
10 246, 251 through 258, 271 through 275, 278, 281 through 287,  
11 289 through 308, 311 through 318, 321 through 324, 326 through  
12 333, 341 through 347, 351 through 358, 371 through 375, 381  
13 through 387, 400 through 456, 461 through 466, 471 through 478,  
14 480 through 500, 502 through 573 and 601 through 603; Santa Fe  
15 county precincts 18, 73, 84 and 85; Torrance county; and  
16 Valencia county precinct 13.

17 B. Congressional district two is composed of  
18 Bernalillo county precinct 31; Catron county; Chaves county;  
19 Cibola county; De Baca county; Dona Ana county; Eddy county;  
20 Grant county; Guadalupe county; Hidalgo county; Lea county;  
21 Lincoln county; Luna county; Otero county; Roosevelt county  
22 precincts 2 through 6 and 19; Sierra county; Socorro county;  
23 and Valencia county precincts 1 through 12 and 14 through 41.

24 C. Congressional district three is composed of  
25 Colfax county; Curry county; Harding county; Los Alamos county;

6 SECTION 3. Section 1-15-16.1 NMSA 1978 (being Laws 1991  
7 (1st S.S.), Chapter 7, Section 2) is amended to read:

8 "1-15-16.1. PRECINCTS.--

9 A. Precinct designations and boundaries used in the  
10 [~~1991~~] 2011 congressional redistricting are those precinct  
11 designations and boundaries established pursuant to the  
12 Precinct Boundary Adjustment Act and revised and approved  
13 pursuant to that act by the secretary of state as of [~~August~~  
14 ~~16, 1991~~] August 31, 2011.

15 B. The boards of county commissioners shall not  
16 create any precinct that lies in more than one congressional  
17 district, nor shall the boards of county commissioners divide  
18 any precinct so that the divided parts of the precinct are  
19 situated in two or more congressional districts. Votes cast in  
20 any general, primary or other statewide election from precincts  
21 created or divided in violation of this subsection shall be  
22 invalid and shall not be counted or canvassed."

23 SECTION 4. TEMPORARY PROVISION--COMPILATION  
24 INSTRUCTIONS.--The compiler shall remove from the NMSA 1978 the  
25 provisions of Section 1-15-15.1 NMSA 1978 (copy of
