## A MEMORIAL 1 RECOGNIZING CIBOLA COUNTY AND DECLARING WEDNESDAY, 2 MARCH 6, 2013 "CIBOLA COUNTY DAY" IN THE SENATE. 3 WHEREAS, Cibola county is New Mexico's newest county, 5 having been created on June 19, 1981; and 6 7 WHEREAS, Cibola county consists of the westernmost 8 four-fifths of the former Valencia county; and 9 WHEREAS, Grants, with a population of over twenty-seven thousand, is the county seat of Cibola county; and 10 WHEREAS, Cibola county is over four thousand five 11 12 hundred square miles in area and consists of one city, one 13 town and twenty-four localities; and WHEREAS, Cibola county is home to the Pueblo of Acoma, 14 the Pueblo of Laguna and the Ramah chapter of the Navajo 15 Nation; and 16 17 WHEREAS, Cibola county features Bluewater lake state park and the nationally protected areas of Cibola national 18 forest, El Malpais national monument and conservation area 19 and El Morro national monument; and 20 WHEREAS, Cibola county contains a larger stretch of 21 historic route 66 than any other county in New Mexico; and 22 WHEREAS, Cibola county is home to six places on the 23 national register of historic places; and

WHEREAS, the Cibola communities economic development

foundation, incorporated, which, in 1994, grew out of the greater Grants industrial development foundation, incorporated, founded in 1982, promotes the economic and industrial base of Cibola county and its communities; and

WHEREAS, Antonio Esparza served as the first president of the Cibola communities economic development foundation, incorporated; and

WHEREAS, the board of directors of the Cibola communities economic development foundation, incorporated, consists of fifteen members who, together, represent Cibola county, the city of Grants, the village of Milan, the Cibola foundation, the Grants/Cibola county chamber of commerce, the Grants-Cibola county school district, New Mexico state university-Grants and private industry;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NEW MEXICO that Cibola county be recognized for its natural beauty and historic and cultural importance; and

BE IT FURTHER RESOLVED that the Cibola communities economic development foundation, incorporated, be recognized for its efforts to foster in Cibola county a thriving economic and industrial environment; and

BE IT FURTHER RESOLVED that Wednesday, March 6, 2013 be declared "Cibola County Day" in the senate; and
