SUMMARY

Synopsis of SRC Amendment

The Senate Rules Committee amendment to House Joint Resolution 2 strikes House Judiciary amendment 1 returning the resolution to the original title.

Synopsis of HJC Amendment

The House Judiciary Committee amendment to House Joint Resolution 2 changes the bill title to read "A Joint Resolution Proposing to Amend Article 7, Section 1 of the Constitution of New Mexico to Remove Reference to Separate School Elections." However, the body of the memorial still states school elections shall be held at different times from partisan elections which was in the original title.

Synopsis of Original Bill

House Joint Resolution 2 would amend Article 7, Section 1 of the New Mexico Constitution to require all school elections be held at different times from partisan elections. The resolution is to be submitted for vote at the next general election or any statewide special election schedule prior

to the next general election.

FISCAL IMPLICATIONS

No funding is provided in this resolution; however, the SOS, in previous analyses, estimates costs at \$100.0 associated with including this item on the ballot of the next statewide election.

SIGNIFICANT ISSUES

The AGO staff analysis, which is neither a formal Attorney General's Opinion nor an Attorney General's Advisory Opinion Letter, finds the joint resolution would "relax" existing restrictions governing the timing of school board elections which currently must be held at different times from *other* elections. This resolution would allow school board elections to be held concurrently with other non-partisan elections.

The PED adds there could be cost savings to school districts if school board elections are combined with other non-partisan elections. However, since this would be determined on a district by district basis, it is not possible to estimate the extent of any savings.

POSSIBLE QUESTIONS

If school board elections are held with other non-partisan elections, would ballots be combined or voted on separately?
