15	SECTION 1. Section 7-2H-3 NMSA 1978 (being Laws 2008,

18	FUNDCREATEDPURPOSEAPPROPRIATIONS
19	A. The "Native American veterans' income tax
20	settlement fund" is created as a nonreverting fund in the state
21	treasury and shall be administered by the taxation and revenue
22	department. The fund shall consist of money that is
23	appropriated or donated or that otherwise accrues to the fund.
24	B. The taxation and revenue department shall
25	establish procedures and adopt rules as required to administer

3 C. Money in the fund is appropriated to the taxation and revenue department to make settlement payments to Native American veterans who were domiciled within the boundaries of their tribal lands or their spouse's tribal lands 7 during the period of their active military duty and had state 8 personal income taxes withheld from their military income, or to their heirs pursuant to applicable law. Settlement payments shall include the amount of state personal income taxes 10 withheld from eligible Native American veterans that have not 12 been previously refunded to the veterans and interest on the amount withheld from the date of withholding computed on a daily basis at the rate specified for individuals pursuant to Section 6621 of the Internal Revenue Code of 1986. No settlement payments shall be made for any taxable year for which a refund claim may be timely filed with the taxation and revenue department, or for which an application for settlement is received after December 31, [2012] 2019. Money shall be disbursed from the fund only on warrant of the secretary of finance and administration upon vouchers signed by the secretary of taxation and revenue or the secretary's authorized representative. Any unexpended or unencumbered balance remaining in the fund at the end of a fiscal year shall not revert to the general fund.

D. Beginning in fiscal year 2010 and in subsequent fiscal years, not more than five percent of the fund is appropriated from the fund to the taxation and revenue department for expenditure in the fiscal year in which it is appropriated to administer the fund. Any unexpended or unencumbered balance remaining at the end of any fiscal year shall revert to the fund.

Beginning in fiscal year 2010 and in subsequent 8 Ε. 9 fiscal years, not more than five percent of the fund is 10 appropriated from the fund to the veterans' services department for expenditure in the fiscal year in which it is appropriated 11 12 to assist in outreach and public relations and in determining eligibility for settlement payments. Any unexpended or 13 unencumbered balance remaining at the end of any fiscal year 14 shall revert to the fund." 15
