11	DECLARING FEBRUARY 3, 2014 "GUADALUPE HIDALGO TREATY DAY" AT
12	THE HOUSE OF REPRESENTATIVES, RECOGNIZING THE SIXTEENTH ANNUAL
13	CELEBRATION OF GUADALUPE HIDALGO TREATY DAY AND COMMEMORATING
14	THE ONE-HUNDRED-SIXTY-SIXTH-YEAR ANNIVERSARY OF THE SIGNING OF
15	THE TREATY OF GUADALUPE HIDALGO BETWEEN THE UNITED STATES OF

18	WHEREAS, on February 2, 1848, the United States of America
19	and the United Mexican States signed the peace treaty known as
20	the Treaty of Guadalupe Hidalgo at the main altar of the old
21	cathedral of Guadalupe at the villa Hidalgo to end the war
22	between the two nations; and
23	WHEREAS, Article VI of the United States constitution
24	affirms that treaties are the supreme law of the land; and
25	WHEREAS, Article 2, Section 5 of the constitution of New

Mexico states that the rights guaranteed to the people of New Mexico under the Treaty of Guadalupe Hidalgo shall be preserved inviolate; and

WHEREAS, Spanish, Mexican and pueblo community land grants throughout New Mexico have continued to use the treaty to protect existing and traditional common lands and pursue justice in the recovery of the former common lands; and

WHEREAS, the New Mexico land grant forum initiated the first-ever Guadalupe Hidalgo Treaty Day at the New Mexico legislature to commemorate the one-hundred-fifty-year anniversary of the signing of the treaty, and the New Mexico land grant council now continues the tradition annually; and

WHEREAS, pursuant to Section 12-5-10 NMSA 1978, February 2 of each year is set apart and known as "Guadalupe Hidalgo treaty day" in New Mexico; and

WHEREAS, February 2, the anniversary of the Treaty of Guadalupe Hidalgo, falls on super bowl Sunday this year, and February 3 is a day on which this treaty's historical significance and continued importance may be given its proper due; and

WHEREAS, the house of representatives, in session February 3, 2014, wishes to extend congratulations and honor this historic event;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that it recognize .196317.1
