10 AN ACT

11 RELATING TO FINANCE; AUTHORIZING THE NEW MEXICO FINANCE
12 AUTHORITY TO MAKE LOANS OR GRANTS FROM THE WATER PROJECT FUND
13 FOR CERTAIN WATER PROJECTS; DECLARING AN EMERGENCY.

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

16 SECTION 1. AUTHORIZATION OF QUALIFYING WATER PROJECTS.--

17 Pursuant to the provisions of Section 72-4A-9 NMSA 1978, the
18 legislature authorizes the New Mexico finance authority to make
19 loans or grants from the water project fund to the following

21 on terms and conditions established by the water trust board
22 and the New Mexico finance authority:
