18	A. An employer shall pay an employee the minimum
19	wage rate of [six dollars fifty cents (\$6.50)] <u>eight dollars</u>
20	<u>thirty cents (\$8.30)</u> an hour [As of January 1, 2009, an
21	employer shall pay the minimum wage rate of seven dollars fifty
22	cents (\$7.50) an hour], except that an employer employing a
23	trainee employee shall pay the trainee employee a minimum wage
24	rate of no less than seven dollars fifty cents (\$7.50) an hour
25	during the training period but for no longer than six months

2 B. Nothing in Subsection A of this section shall be construed to authorize or require an employer to lower the 3 hourly wage of an employee.

[B.] C. An employer furnishing food, utilities, supplies or housing to an employee who is engaged in agriculture may deduct the reasonable value of such furnished items from any wages due to the employee.

[G.] D. An employee who customarily and regularly receives more than thirty dollars (\$30.00) a month in tips 10 shall be paid a minimum hourly wage of two dollars thirteen 12 cents (\$2.13). The employer may consider tips as part of wages, but the tips combined with the employer's cash wage 14 shall not equal less than the minimum wage rate as provided in Subsection A of this section. All tips received by such 16 employees shall be retained by the employee, except that nothing in this section shall prohibit the pooling of tips 18 among employees.

 $[\underline{D_{\cdot}}] \underline{E_{\cdot}}$ An employee shall not be required to work more than forty hours in any week of seven days, unless the employee is paid one and one-half times the employee's regular hourly rate of pay for all hours worked in excess of forty hours. For an employee who is paid a fixed salary for fluctuating hours and who is employed by an employer a majority of whose business in New Mexico consists of providing .198154.1
