SUMMARY

Synopsis of Bill

The House Energy, Environment and Natural Resources Committee Substitute for House Bill 624 amends Section 72-1-10 NMSA 1978 to subject the Albuquerque-Bernalillo County Water Utility Authority (Authority) to Public Regulation Commission (PRC) jurisdiction and provisions of the Public Utility Act.

FISCAL IMPLICATIONS

There would be a minimal administrative cost associated with this bill, and PRC would generate very minimal revenues from fees charged to the Authority.

SIGNIFICANT ISSUES

The bill would provide PRC regulation over the Authority, adding oversight of rates and quality and reliability of service. However, PRC notes that by requiring the Authority to submit requests to PRC for rate increases, the Authority would incur additional administrative and legal costs for rate case preparation and hearings.

The Albuquerque-Bernalillo County Water Utility Authority was created in 2003 to make policy decisions about water and sewer usage, set water and sewage rates, and establish drought restrictions and other water regulations and ordinances. The duties of the Authority are complex, and the Authority is empowered to approve major water utility projects and to issue bonds to finance those projects.

The Authority's board of directors is currently composed of the mayor of Albuquerque, three city councilors and three county commissioners. The membership of the board may change on an annual basis at the pleasure of the president of the Albuquerque City Council and the chair of the Bernalillo County Commission. Additionally, a member of the Albuquerque City Council may designate another member to serve in the member's absence, a member of the Bernalillo County Commission may designate another member to serve in the member's absence, and the mayor of Albuquerque may designate the chief executive officer of Albuquerque, a member of the Albuquerque City Council, or a member of the Bernalillo County Commission to serve in the mayor's absence, creating the potential for a lack of institutional knowledge among the members at a particular meeting.

ADMINISTRATIVE IMPLICATIONS

There would be a minimal administrative burden to regulate the Authority and hear rate cases.

OTHER SUBSTANTIVE ISSUES

The regional water plan for the middle Rio Grande identified an existing gap between regional water supply and demand that is expected to grow without focused and intensive actions to stop it. Additionally, concerns have been raised as to the testing and treating of drinking water, as well as the handling of the jet fuel spill originating at Kirtland Air Force Base.
