## SUMMARY

#### Synopsis of Bill

Senate Bill 68 amends Sections 73-14-19-22, NMSA 1978, Chapter 73, Special Districts which addresses the composition of boards of directors for conservancy districts. Both the existing statute and proposed bill provides for seven board members–three members from the most populous county, one from each of the remaining counties (three members); and one at-large member.

Under the proposed amendment however, the three seats from the most populous county would be subdivided into three compacted districts with acreage apportioned as equally as possible. One director will be elected from each of these compacted districts.

Board members will be required to have or establish residency in their respective districts no later than January 1, 2017. The bill repeals conflicting provisions in Section 73-14-22.

## FISCAL IMPLICATIONS

SB 68 carries no appropriation and has no fiscal impact.

## SIGNIFICANT ISSUES

Proposed corrections and changes to the current statute will allow the conservancy districts to be better represented in the most populous district. Thus, the changes as proposed in this bill will affect specifically Bernalillo County in the Middle Rio Grande Conservancy District.

The Middle Rio Grande Conservancy District board of directors is currently represented by one member each from Sandoval County, Socorro County, and Valencia County; one member atlarge, who may reside in any of the listed counties, and three members from Bernalillo County. Currently the three members on the Board representing Bernalillo County all reside in the northwest sector of that county.

If SB 68 is enacted, the new board members will be elected from and by the qualified electors of each compact district.

The changes also include a repeal in Section 73-14-22 board of directors; apportionment to be moved to Section 73-14-19. The apportionment of the three compact single-member districts will be completed by January 1, 2017, which will coincide with the new election of board members.

## **TECHNICAL ISSUES**

AGO analysis recommends that adding "either" in Section A(2) after "resides" makes for easier reading comprehension.
