#### **SUMMARY**

#### Synopsis of Bill

House Memorial 70 requests the Regulation and Licensing Department to convene a working group of stakeholders to address recommendations for laws to reduce companion animal overpopulation and increase companion animal welfare in the state, including pet store bans and licensing of commercial animal breeders. The working group will include:

- the Animal Sheltering Board Chair;
- a representative from county and municipal animal shelters;
- a representative from a nonprofit humane society or animal rescue organization;
- a representative from an animal advocacy group;
- a representative of pet store owners;
- a member of the animal law section of the state bar; and
- one member of the public.

#### **House Memorial 70 – Page 2**

The bill requires the working group to report its findings and recommendations, including an estimate of the recommendations' fiscal impacts, to the appropriate interim legislative committee by August 1, 2016.

#### FISCAL IMPLICATIONS

This bill does not state if members of the working group would receive per diem for their participation in this study. Possible expenditures could include per diem for the Animal Sheltering Board Chair or other costs associated with hosting meetings if the working group convenes at the Toney Anaya building. Estimated fiscal impacts to the Animal Sheltering Board operating budget could reach up to \$3,000, depending on how the working group is convened for this study.

### **SIGNIFICANT ISSUES**

The Animal Sheltering Board conducted a feasibility study on funding low-income households for sterilizing, vaccinating, and spaying or neutering their companion animals. This report was prepared in response to Senate Memorial 36 of the 2011 regular legislative session. According to the report, in 2011 New Mexico's euthanasia agencies (most animal shelters) took in 118 thousand homeless cats and dogs. These agencies had a total annual budget of \$27 million and euthanized 55,000 cats and dogs. Animal euthanasia costs approximately \$225 per animal.
