SUMMARY

Synopsis of Bill

Senate Bill 102 is an appropriation of \$1.4 million from the pubic project revolving loan fund (PPRF) to the wastewater facility construction fund for expenditure in fiscal year 2017, and subsequent fiscal years, providing state matching funds for the federal Clean Water Act projects

and to carry out the purposes of the wastewater facility construction loan act. Any unexpended or unencumbered balance remaining at the end of the fiscal year shall not revert to the public project revolving loan fund.

FISCAL IMPLICATIONS

SB 102 appropriates \$1.4 million from the PPRF to the wastewater facility construction loan fund. This state match will leverage \$6.558 million of federal funding to be used in New Mexico in for eligible wastewater and storm water projects statewide. The New Mexico environment department's construction programs bureau administers the wastewater facility construction loan fund. The matching funds are requested annually for the capitalization grants from the U.S. Environmental Protection Agency to carry out the purposes of the Clean Water Act. The appropriation is an eligible appropriation from the PPRF as administered by the New Mexico finance authority.

SIGNIFICANT ISSUES

The wastewater facility construction loan fund, also known as the clean water state revolving loan fund (CWSRF) was established in 1986 pursuant to the Wastewater Facility Construction Loan Act and the federal Clean Water Act. The CWSRF program provides low-interest loans (0% to 3%) with a term of thirty years, and when permitted through the federal capitalization grants a loan subsidy is provided, to municipalities, counties, water and sanitation districts, mutual domestics, and tribes. Funding supports the planning, design and construction of wastewater collection and treatment projects, in addition to non-point source water pollution control projects. To date, NMED reports \$372.2 million has been awarded to communities statewide from the CWSRF.

CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

HB 160 duplicates SB 102 in its entirety.

WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL

The State, through NMED, would need to find an alternative state match to secure federal funding for the annual capitalization grant anticipated to be \$6.558 million under the Clean Water Act.
