12	VALUATION INCREASES FOR LOW-INCOME DISABLED PERSONS.

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	SECTION 1. Section 7-36-21.3 NMSA 1978 (being Laws 2000,
16	Chapter 21, Section 1, as amended) is amended to read:
17	"7-36-21.3. LIMITATION ON INCREASE IN VALUE FOR SINGLE-
18	FAMILY DWELLINGS OCCUPIED BY LOW-INCOME OWNERS WHO ARE SIXTY-
19	FIVE YEARS OF AGE OR OLDER OR DISABLEDREQUIREMENTS
20	PENALTIES
21	A. The valuation for property taxation purposes of
22	a single-family dwelling owned and occupied by a person who is
23	sixty-five years of age or older or disabled and whose modified
24	gross income for the prior taxable year did not exceed the
25	greater of thirty-five thousand dollars (\$35,000) or the amount

1 calculated pursuant to Subsection F of this section shall not 2 be greater than the valuation of the property for property taxation purposes [in the]: 3 for a person sixty-five years of age or 4 (1) 5 older: (a) in the tax year in which the owner's 6 7 sixty-fifth birthday occurs, if the owner owns and occupies 8 that property; or 9 [(2)] (b) in the tax year following the tax year in which an owner who is sixty-five years of age or 10 older first owns and occupies the property; or 11 12 (2) for a person who is disabled in the tax year in which the owner first files an application for the 13 limitation provided by this section. 14 Β. The limitation provided by this section may be 15 claimed by filing proof of eligibility with the county assessor 16 on an application form furnished by the assessor. 17 The application form shall be designed by the department and shall 18 provide for proof of age or disability, occupancy and income 19 20 eligibility. An owner who applies for the limitation of value specified in this section and files proof of income eligibility 21 for the three consecutive years immediately prior to the tax 22 year for which the application is made need not claim the 23 limitation for subsequent tax years if there is no change in 24 eligibility. automatically in subsequent tax years until a change in
 eligibility occurs.

An owner who has claimed and been allowed the 3 C. limitation of value specified in this section for the three 4 consecutive tax years immediately prior to the 2020 tax year is 5 not required to claim the limitation for subsequent tax years 6 7 if there is no change in eligibility, unless the county assessor requests updated information on the owner's modified 8 9 gross income. The county assessor shall apply the limitation automatically in subsequent tax years until a change in 10 eligibility occurs. 11

D. A person who has had a limitation applied to a tax year and subsequently becomes ineligible for the limitation because of a change in the person's status or income or a change in the ownership of the property against which the limitation was applied shall notify the county assessor of the loss of eligibility for the limitation by the last day of February of the tax year immediately following the year in which loss of eligibility occurs.

E. A person who knowingly violates the provisions of this section by intentionally claiming and receiving the benefit of a limitation to which the person is not entitled or who fails to comply with the provisions of Subsection D of this section shall be liable for all taxes due, interest and a civil penalty of one thousand dollars (\$1,000).

F. For the 2020 tax year and each subsequent tax year, the maximum amount of modified gross income in Subsection A of this section shall be adjusted to account for inflation. The department shall make the adjustment by multiplying thirtyfive thousand dollars (\$35,000) by a fraction, the numerator of which is the consumer price index ending during the prior tax year and the denominator of which is the consumer price index ending in tax year 2019. The result of the multiplication shall be rounded down to the nearest one hundred dollars (\$100), except that if the result would be an amount less than the corresponding amount for the preceding tax year, then no adjustment shall be made.

G. The department shall publish annually the amount determined by the calculation made pursuant to Subsection F of this section and provide the calculated amount to each county assessor no later than December 1 of each tax year.

H. The limitation of value specified in SubsectionA of this section does not apply to:

(1) a change in valuation resulting from any physical improvements made to the property during the year immediately prior to the tax year or a change in the permitted use or zoning of the property during the year immediately prior to the tax year; or

(2) a residential property in the first tax year that is valued for property taxation purposes.
