15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. AUTHORIZATION OF PROJECTSPursuant to
17	Section 6-21-6 NMSA 1978, the legislature authorizes the New
18	Mexico finance authority to make loans from the public project
19	revolving fund for public projects as defined in Section 6-21-3
20	NMSA 1978. Pursuant to Section 6-21-6 NMSA 1978, loans of one
21	million dollars (\$1,000,000) or less do not require specific
