## SUMMARY

### Synopsis of House Memorial 33

House Memorial 33 (HM33) requests the Higher Education Department to convene a taskforce to study and develop recommendations, and draft legislation for collecting data on parenting students in the New Mexico higher education system. The memorial names specific task force members including staff from higher education institutions, parenting students, a member of the children's cabinet, a representative from the Higher Education Department, and a representative from the New Mexico student parent alliance.

The taskforce report is to include an assessment of the current status of parenting student data collection and recommendations for implementing statewide data collection for higher education institutions. The report and recommendations are to be presented to the Legislative Health and Human Services Committee and other committees by November 1, 2026.

## **FISCAL IMPLICATIONS**

Memorials do not contain appropriations and are not enforceable as state law. The study requested in this memorial is within the normal operations of the agencies involved and is unlikely to result in significant costs. HED notes that should the taskforce meet virtually, there will be little additional costs, but in-person meetings could result in additional travel costs. New Mexico Tech estimated the costs of updating IT systems to track the data required would impose an additional cost of approximately \$8 thousand. This cost would affect institutions statewide and would be absorbed in the current operating budget.

## **SIGNIFICANT ISSUES**

HED notes that collection of additional data on student parents could help determine whether student parents are persisting and completing at lower rates and could help direct student support strategies. The independent community colleges report that approximately 30 percent of community college students in the U.S. care for dependent children.
