WHEREAS, Los Alamos National Laboratory has been at the forefront of scientific endeavors for eighty years and has achieved recognition as one of the United States of America premier research institutions; and

WHEREAS, Los Alamos National Laboratory is the most significant industry in Northern New Mexico employing approximately Fourteen Thousand (14,000) employees, purchasing approximately Nine Hundred and Fifteen Million (\$915,000,000) in goods and Services and paying approximately One Hundred Thirty Six Million (\$136,000,000) in gross receipts tax revenue in 2022; and

WHEREAS, the residents of Northern New Mexico built and have maintained Los Alamos National Laboratory since its beginning in the early 1940's and are still today an indispensable component of the workforce; and

WHEREAS, approximately 55% of Los Alamos National Laboratory employees reside in surrounding Counties and Pueblos; and

WHEREAS, the local revenue distribution from the Los Alamos National Laboratory gross receipts tax currently paid to the State of New Mexico disproportionately benefits Los Alamos County; and

WHEREAS, the State of New Mexico has enacted unique legislation to require Los Alamos National Laboratory to pay gross receipts tax, regardless of whether the entity operating the Laboratory is a not for profit.
