**THIRD READING OF LEGISLATION**

1. SENATE BILL 24, as amended, with emergency clause. AN ACT RELATING TO FLEXIBILITY FOR PUBLIC SCHOOLS; MAKING AN APPROPRIATION FROM THE PUBLIC SCHOOL CAPITAL OUTLAY FUND TO PAY FOR PROPERTY INSURANCE ON BEHALF OF SCHOOL DISTRICTS AND CHARTER SCHOOLS DURING FISCAL YEAR 2010; AMENDING THE GENERAL APPROPRIATION ACT OF 2009 TO DEDUCT A PORTION OF THE AMOUNT IN THE STATE EQUALIZATION GUARANTEE RELATED TO PROPERTY INSURANCE; DECLARING AN EMERGENCY.
