Synopsis of Bill

House Bill 1 appropriates \$24 million from the general fund and cash balances to various legislative agencies for the purpose of funding operation of the 2013 legislative session and funding for interim activities, including fiscal year 2014 operating budgets of the Legislative Council Service, Legislative Finance Committee, Legislative Education Study Committee, and the House and Senate chief clerk offices. Other appropriations include legislative interim expenses, session preparation, statewide legislative internship program, expenses of the Senate Rules Committee, and legislative information system.

FISCAL IMPLICATIONS

The appropriation of \$8,639.7 thousand contained in this bill funds the expenses of the 51st Legislature, First Session and includes \$400 thousand from cash balances for the extensible markup language data base for expenditure during FY13 and FY14.

The appropriations totaling \$15,010.0 thousand contained in this bill for legislative offices and other interim expenses are a recurring expense to the general funding, including \$632 thousand for the legislative information system for expenditure in FY13 and FY14.
