SIGNIFICANT ISSUES

The Senate Conservation Committee Substitute for Senate Memorial 43 tasks the Economic and Rural Development Interim Committee to study the potential for recycling or reuse of certain waste materials in rural areas. Other participants include the New Mexico Farm and Livestock Bureau, the New Mexico State University Cooperative Extension Service, New Mexico's Soil and Water Conservation Districts, the New Mexico Municipal League, the New Mexico Association of Counties, the Department of Environment and other interested parties.

The goal of this collaborative study group is to address repurposing certain materials and wastes that are common throughout the state. Such topics of study must include the repurposing of: composting waste; rubber tires; farm, dairy and ranch waste; landfill waste; and sludge from wastewater and water utilities.

Any findings and recommendations resulting from the study are due to the legislature.

OTHER SUBSTANTIVE ISSUES
