SUMMARY

Synopsis of Bill

House Bill 221 proposes to amend Section 43-1-10 to allow law enforcement detain and transport a person, enter the structure occupied by the person if a physician, psychologist, or qualified mental health professional certifies the person presents a likelihood of serious harm to self or others. It removes the requirement that the person be seen on an emergency basis by a certified psychologist or psychiatrist and allows the person be detained and transported by law enforcement to an evaluation facility. The bill also provides where feasible for a law enforcement crisis intervention team to be involved in the detention and transportation

SIGNIFICANT ISSUES

According to the Administrative Office of the Courts (AOC), HB221 is not clear how a psychiatrist would make such a determination that would allow officers to detain persons suspected of harming themselves or others and transport them for evaluation with only a certification from a psychiatrist.
