## **Federal Funds Update**

## Large Nonrecurring Federal and State Appropriations

- As of September 19, 2022, state agencies committed a total of \$304.3 million or about \$27.1 million more than was reported expended for the last federal funds update in mid-August 2022. Spending so far accounts for about 15 percent of the \$2 billion in large nonrecurring appropriations that are being tracked in this report.
- State agencies spent \$92.7 million of \$1.2 billion allocated for post-pandemic economic recovery. Larger unspent economic recovery items include \$70 million for business space development, \$348 million for statewide road projects, and \$45 million for research and development at higher education institutions.
- For post pandemic workforce development, of \$390 million appropriated, state agencies spent about \$41.4 million. The Higher Education Department has not transferred the \$130 million it received for the lottery tuition fund.
- Of the \$95 million in higher education faculty teaching endowments for social workers and nurses, \$60.5 million in notices of awards have been sent out.
  - Eleven awards for a total of \$30 million were made to nursing programs including \$6.5 million to the University of New Mexico Health Sciences Center, \$3 million to Central New Mexico Community College, and more to New Mexico Highlands University (NMHU), New Mexico State University (NMSU), and Western New Mexico University (WNMU). The endowments will support 14.5 new faculty and 169 new student slots.
  - Three awards, for a total of \$30.5 million were made for social work endowments comprising \$8 million to NMHU, \$16.5 million to NMSU, and \$6 million to WNMU. The endowments will support 14 new faculty and 200 new student slots.
- For pandemic response and improving healthcare, \$144.3 million, or about 57 percent was spent. Larger unspent items include \$34 million for affordable energy efficient housing, and \$20 million for behavioral health provider startup costs.
- For other appropriations, about \$25.8 million, or 14 percent has been spent. Larger unspent items include \$70 million for the Santa Fe executive office building and \$67 million for criminal justice reform and police salaries.
