








Beer, Wine & Spirits Wholesalers

Beer, Wine, & Spirits Wholesalers

- Three Tier System Benefits

Regulatory

- Facilitates state and local control within licensed system
- Orderly markets for alcohol
- Responsible competition

Economic

- Efficient and timely tax collection
- Business growth with growing number of brewers, distillers, and winegrowers
- Wholesaler economic impact

Commercial

- Equal access to the market a level playing field
- Retailer has enormous selection
- Consumer has vast choice

Wholesaler Employment

- Combined wholesaler employment provides 1,300 New Mexican jobs.
- Full-time benefits include health, dental & vision insurance, 401(k), paid vacation, life insurance.
- Non-college degreed long-term career paths.











Taxes Paid

- New Mexico annual payroll taxes remitted: \$3.8M*
- County annual real estate & personal property taxes: \$500K+*
- Other New Mexico taxes paid:
 - Diesel and gasoline taxes
 - Heavy vehicle mileage-based tax
 - Gross receipts taxes on services and non-resale products we buy locally
 - Compensating tax on services and non-resale products we buy out of state

Alcohol Excise Taxes

- Alcohol excise taxes are levied by volume sold by wholesalers by most states since Prohibition was repealed in 1933.
- Alcohol excise tax is a *tax on consumers*, not on wholesalers, and impacts *consumers'* cost of living.
- Wholesalers' role is tax collection and timely remittance to New Mexico Taxation & Revenue by the 25th of the month following sale.



 Wholesalers are efficient, reliable, and timely tax collectors and remitters.

Alcohol Excise Tax – "Cents per Drink"

Recent legislative sessions – a \$0.25 per drink increase has been proposed.







- Real impact of that on New Mexican consumers:
 - New Mexico off-premise beer retail leading volume package size is the 30-pack of 12 oz. beer.
 - $\$0.25 \times 30 12$ oz. beers = \$7.50 tax increase
 - Average off-premise retailer gross margin is approximately 25%.
 - Price to consumers will increase by about \$10.00 + GRT per 30-pack purchase.
 - That's an average of 30-37% retail price increase at the register to the consumer.

Alcohol Excise Tax

-"No Increase in 30 Years"

- New Mexicans' personal income per capita is one of the lowest regionally.
- Our alcohol taxes are the highest regionally, taking a disproportionately higher share of New Mexicans' lower disposable income.



Alcohol Excise Tax - "No Increase in 30 Years"

















Wholesaler Employment Careers
