


## NMDOT DISTRICT FIVE TRANSPORTATION INFRASTRUCTURE REVENUE SUBCOMMITTEE June 5, 2025

District Five encompasses San Juan, Rio Arriba, Taos, Santa Fe, Torrance, and Los Alamos Counties, with District Five Headquarters located in Santa Fe. District Five is responsible for maintaining approximately 5,375 lane miles of roadway and is comprised of 21 Maintenance Patrols, 5 Construction Offices and 7 Special Crews. The District also works closely with ten tribal governments and seventeen local governmental entities to meet our transportation goals.




