2. Has the Developmental Disabilities Supports Division of the Department of Health provided the DDPC any documents in the last three years that contain a breakdown of the qualifying conditions (i.e. Cerebral Palsy, Down's syndrome, and Autism Spectral Disorder) of persons who are?

B. The breakdown of qualifying conditions for those Developmentally Disabled persons who applied for services or found employment?

5. Has the Public Education Department provided the DDPC any documents in the last three years that specifically include?

A. The number of developmentally disabled students that are receiving Speech, Occupational and Physical therapy at levels recommended in their individual educational plans
