OMBPS is requesting a flat budget this year

- Originally planned to ask for a plus up this year
- However, my focus changed as I interacted with military and civil leadership
 - Working closely with the Commission to identify effective investments
- I expect to ask for a plus up next budget cycle



Mission

Mission by Statute (prevent closure due to BRAC):

- Understand the federal government's plans, policies, and initiatives relative to military base realignment and closure
- Collaborate with and assist community organizations
- Coordinate with and assist the State's Congressional Delegation
- Inform the Governor and the Lieutenant Governor regarding issues impacting the military bases in the State

Evolved Mission (promote growth and ensure installation value):

- Strengthen installations and communities by advocating & investing in programs to improve the <u>quality of life</u> for military families
- Work with communities and developers to identify and address <u>encroachment</u> issues early so that critical training and operations areas are not impacted.
- Invest in and advocate for improvements to <u>critical infrastructure</u> supporting military installations and communities resilience is an important facility metric
- Work closely with EDD to enhance <u>economic growth</u> around military communities



Challenges

The DOD Value Process:

- DOD process for choosing new locations, new facilities, and mission expansion is increasingly competitive
- AF uses Report Cards to grade each installation and this drives their decision process
 - Public Education
 - Licensure Portability
 - Healthcare <new>
 - Housing <new>
- Five to Thrive Program was initiated by the spouse of the Chief of Staff of the Air Force, Sharene Brown in Dec 2021 and expands on the Report Cards
 - Childcare
 - Education
 - Healthcare
 - Housing
 - Spouse employment/Licensure portability
- The DOD is now pushing for multi-state compacts for greater prof. transparency



Challenges (cont)

2024 DOD Policy Priorities

- Military Access to Quality Family Child Care
- Military Spouse Employment and Economic Opportunities (Compacts and implementing the federal law)
- Defining Armed Forces
- Military Community Representation on State Boards and Councils
- State Support for Military Families with Special Education Needs
- Military Family Anti-Discrimination Status
- State Response to Military Interpersonal Violence
- Concurrent Juvenile Jurisdiction

Encroachment

- Physical (structure locations and height)
- RF & Optical



Focus

Installation value in NM driven by how we address these challenges

- NM 2022 HB191 was big step for reciprocity
 - o NM now green across the board on professional licensure reciprocity
 - Now we have to address the multi-state compacts issue
- Childcare, education, healthcare, & housing remain issues
 - o These aren't unique to installation communities, or NM nationwide
- Encroachment solutions just require more communication ...

Approach

 The OMBP & the Commission are working with Legislative Leaders and Office of the Secretary of Defense to develop solutions

Military installation impact (2022)

- 52,268 jobs
- \$2.8 Billion in labor income
- \$14 Billion in industrial output
