Site Security Assessment Example

Observations:

Large interior/exterior single/double pane classroom/office windows and/or door glass could be easily compromised by severe weather or a violent intruder.

Recommendations:

To reinforce and slow violent intrusion or after-hours break-in, consideration should be given to the installation of window security film on existing window/vision panels on newer classroom/office doors; as well as window panels exceeding 12 inches in width and that are less than 6 feet from the ground.

Standards:

FEMA BIPS 07-Primer To Design Safe School Projects (Section 2.49) Windows overlooking or directly exposed to public streets or dangerous areas should be either minimized or protected. Window glazing should be laminated or protected with an anti-shatter film. Glass-clad polycarbonate and laminated polycarbonate are two types of alternative glazing material.


