Supporting Schools in summertime:

- Schools can also temporarily suspend service to each student line for up to 3 months in a 12-month period.
- During the suspension, the monthly service charge for the data plan will be reduced to \$0.01/month, bill credits will cease, and the service charge for Enterprise Traffic Protector will be waived.
- Installment agreement charges for equipment, if any, are not eligible for a temporary suspension.
- Suspending service does not extend service discounts past 9/30/22.

*Please read the important requirements:

- This is a limited time offer (ends 9/30/20 in Puerto Rico) and is available for existing or new public and private K-12 schools, colleges and university customers on existing or new agreements
