Create and Maintain a Data-Sharing Network

FY 2020 (\$510,000)

- Funded the majority of a Project Manager position to oversee statewide data integration.
- Went to contract with New Mexico Tech's Institute for Complex Additive Systems Analysis (ICASA) to fund initial project focused on implementing the use of the state identification number (SID) throughout New Mexico's criminal justice system.

FY 2021 (flat request -- \$510,000)

- No additional amount requested for FY 2021.
- Continue to fund Project Manager.
- Identify priority area(s) for Year 2 of data-sharing network work.

Crime Reduction Grants FY 2020

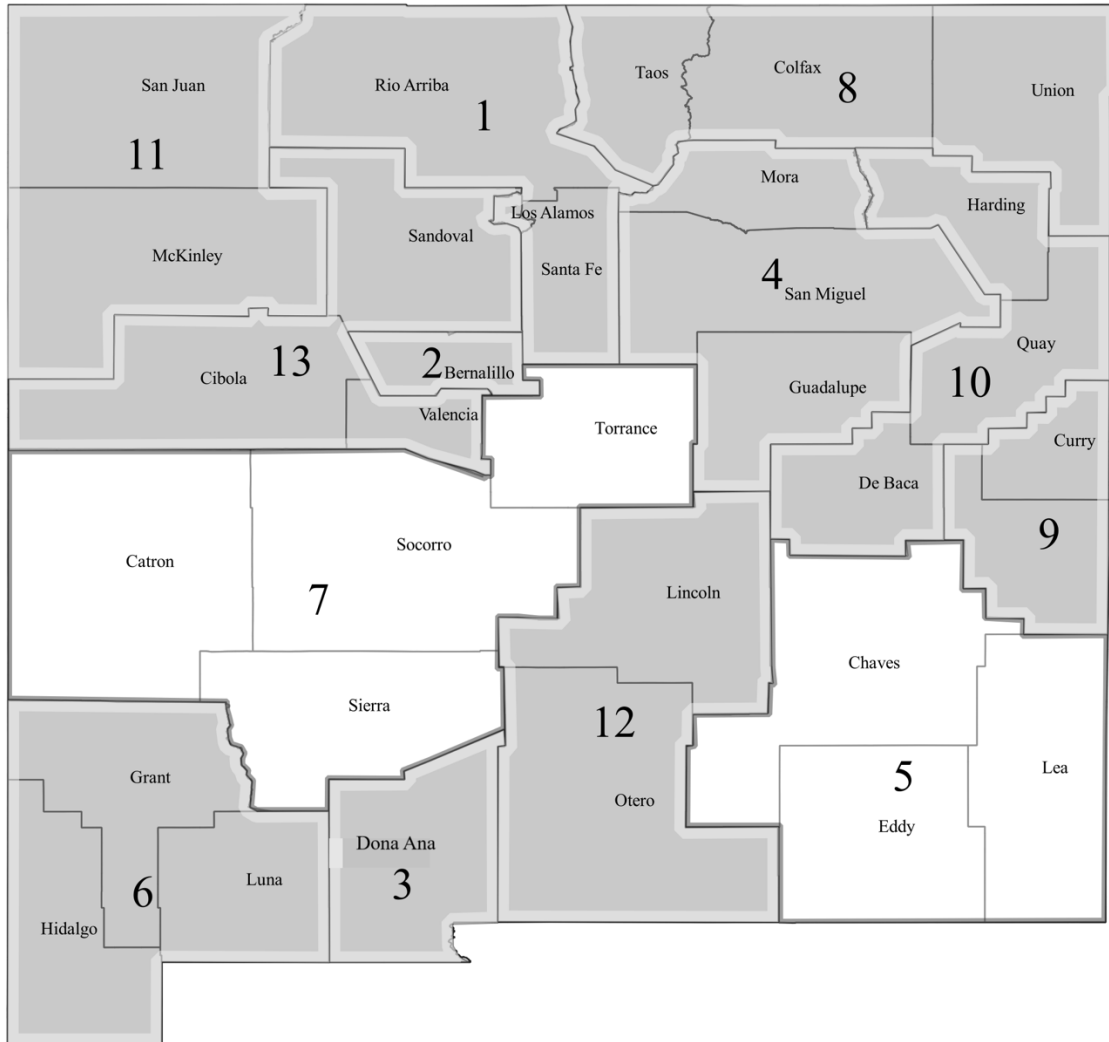
- Received \$178,500 recurring and \$218,500 non-recurring (Total: \$397,000).
- Published grant application guidelines for data integration.
- Recorded two webinars for statewide grant process participants and distributed them online.
- Contacted all 13 CJCCs and visited seven.
- Collected applications totaling \$784,192 in requested funds.
- NMSC Grants Committee awarded \$377,150 in criminal justice data-sharing grants to seven projects representing 11 CJCCs.
- IGAs with each grant award winner are complete or nearly completed.
- Provided technical assistance in the form of in-person stakeholder process mapping sessions with each of the winning projects.
- Provided stakeholder coordination assistance to all CJCCs, including developing relationships across a statewide contact list of 250 individuals (and growing) representing IT and records functions within jails, DA offices, LOPD offices, law enforcement agencies, district courts, and service providers across the state.
- Connected CJCCs to state-level efforts by NM Tech for the SID and other related projects.
- Funded a portion of Project Manager position to oversee statewide data integration.



Crime Reduction Grants FY 2021

- Requesting a total of \$750,000 – an increase over the FY 2020 total funding for crime reduction grants by \$353,000.
- The difference between requested FY 2020 grants and amount available to be awarded was \$407,042.
- Will roll out Crime Reduction Grants Application 2.0, with more time for technical assistance, idea generation, and stakeholder engagement.
- Will push to get applications from all 13 CJCCs.
- Make grants available for statutorily enumerated areas not funded in FY 2020 (treatment and supervision alternatives to incarceration; preprosecution diversion or specialty court programs; pretrial service programs).
