AGENCY OVERVIEW

Programmatic Areas

- Adult Protective Services: Investigating abuse, neglect, and/or exploitation for adults eighteen and over.
- Aging Network: Contracting of direct services through AAA's for employment, healthy aging, meals & nutrition, and transportation.
- Office of Indian Elder Affairs: Leading efforts to support Native elders by managing tribal relationships, administering state contracts, and providing outreach and technical services.
 - **Consumer & Elder Rights**: Assisting elders, persons with disabilities and caregivers to find the services and resources they need.

Long-Term Care Ombudsman Program: Advocating for long-term care residents' rights and ensuring they receive the care they deserve.

Long-Term Care Services: Providing caregiver, care transition, Alzheimer's & dementia, and veteran's services.

Agency Mission

To provide accessible, integrated services to older adults, adults with disabilities, and caregivers, to assist in maintaining their independence, dignity, health, safety, and economic well-being, thereby empowering them to live independently in their own communities as productively as possible.





GAINING MORE OLDER ADULTS WHO ARE LIVING LONGER

New Mexico's 65+ age category is projected to have **the greatest growth of any age group**, increasing by more than 80,000 between 2020 – 2040.


Catron, **Harding**, and **Sierra** Counties have the highest percentages of adults 60+.


An estimated **525 centenarians live here**, a **28% increase** from 2020 (410 centenarians).

42% of New Mexico seniors have an annual income of **less than \$40k**.

9% of New Mexico seniors have an annual income of **less than \$10k**

A 2024 Older Adults Needs Assessment by UNM showed that **78%** of aging service providers reported challenges in recruiting direct service employees.

NEW MEXICARE

Providing financial assistance and training to caregivers who are assisting friends or family members (non-Medicaid; ages 60+) with daily activities as a result of physical or cognitive limitations.

The goal of the program is to allow older adults to thrive in their homes and communities and reduce nursing home placements and emergency department visits.





- Increasing reports across the state year by year
- Increased recidivism of cases
- Increased complexity of client needs:
 - Behavioral Health Homelessness Co-Occurring Disorders
- No. 1 investigated report for NM is Self-Neglect
- Approximately 50% of reports related to dementia/Alzheimer's

*National trends show an increase in Adult Protective Services (APS) referrals, with a significant rise from 2016 to 2018 (15.2%) and a 19% increase in referrals between 2019/20 and 2021/22. This growth is linked to increasing awareness of elder mistreatment and a growing elderly population, with self-neglect often being the most common type of maltreatment investigated.

AGING NETWORK - SUPPORT AND PROGRAMS

The Aging Network Division oversees several OAA funded programs that provide support and services to older adults across New Mexico. ALTSD contracts with the Area Agencies on Aging (AAAs) to provide services within each of the planning and service areas (PSAs) to older New Mexicans through nutrition education, meals (including in-center, grab-n-go, and home-delivered), transportation, social services and health promotion. The Office of Indian Elder Affairs operates the Indian Area Agency on Aging division within AND.



The conference forges meaningful connections, educates seniors and Native elders, providers, and caregivers from around the state.










Conference Attendees by County





OUTREACH AND PUBLIC COMMUNICATION

Outreach and public communication is the bridge between the agency and the public, including the media, legislators, stakeholders, and the communities the agency serves.

Awareness gap: Many older adults, caregivers, and rural residents remain unaware of ALTSD's programs, especially the Aging and Disability Resource Center (ADRC), Adult Protective Services (APS), and the Aging Network.

Limited marketing budget: ALTSD currently operates outreach with minimal general fund support, relying on aging network partnerships and earned media.

Growing demand: New Mexico's 60+ population is one of the fastest-growing in the nation, with one in three New Mexicans projected to be over the age of 60.

Digital divide: Many seniors are not reached through digital channels, requiring targeted local radio, print, and community-based outreach that costs more but ensures equity.





KIKI SAAVEDRA **SENIOR** DIGNITY FUND -LIFELINE FUNDING FOR NM AGING **POPULATION**

The Kiki Saavedra Senior Dignity Fund provides vital resources to address the most pressing needs of older adults, such as transportation, nutrition, health care, and caregiving.

Amount ALTSD is authorized to spend \$2,275,000/fiscal year in base budget.

FEDERAL APPROVAL OF 2025-2029 STATE PLAN ON AGING

GOAL 1:

Administer and expand core programs that enable older New Mexicans to remain in their residence and community through the availability of and access to high-quality home and community services and supports, including supports for families and caregivers.

GOAL 2:

Promote equity and well-being for older adults with greatest economic and social need across New Mexico by responding to social determinants of health, including food and housing security, social support and connection, employment and meaningful engagement, and access to information and health services.

GOAL 3:

Reduce occurrences of abuse, neglect and exploitation while improving outcomes in communities and long-term care settings and preserving the rights and autonomy of older New Mexicans.

GOAL 4:

Assist Tribes, Pueblos and Nations in accessing Title III funding and enhance coordination between Title III and Title VI programs
