

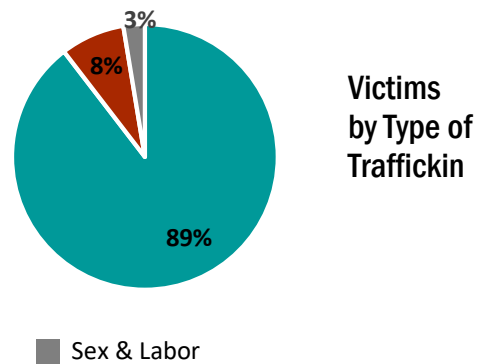
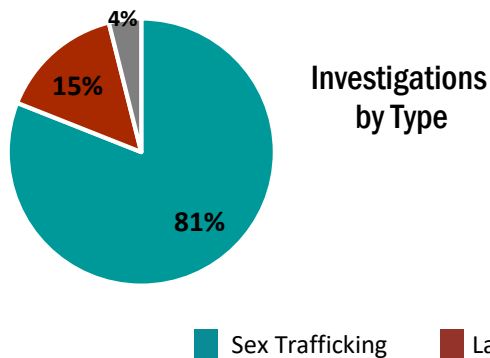
New Mexico Human Trafficking Task Force 2016-2018 Data Snapshot

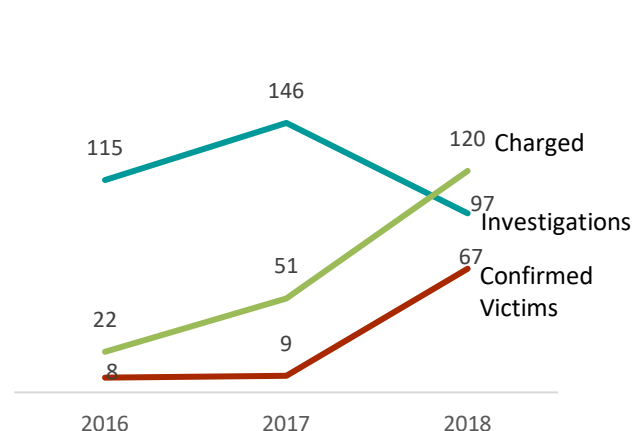
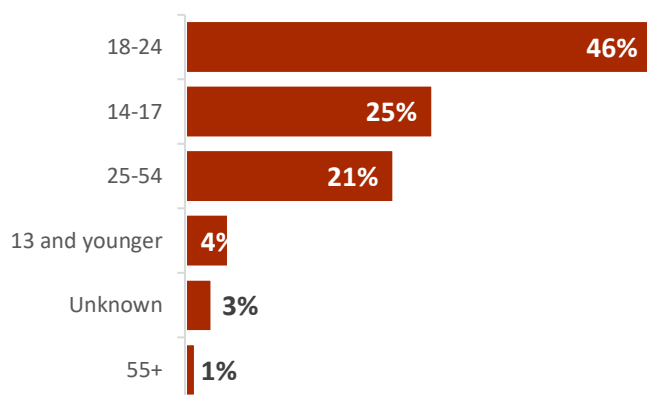
Most of the Victims were female

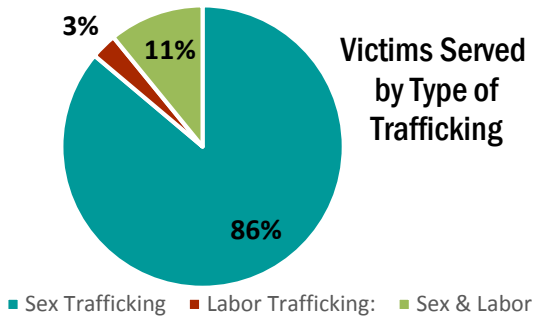

New Mexico Human Trafficking Task Force 2016-2018 Victim Services Snapshot

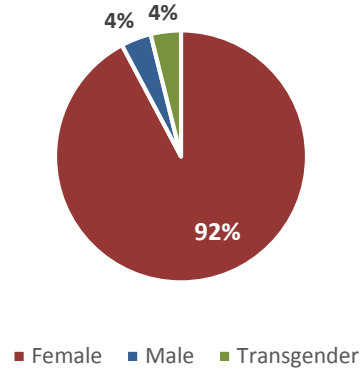

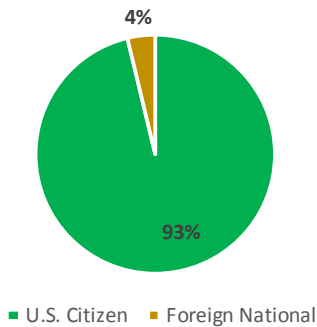
103 victims were served in 2016-2018



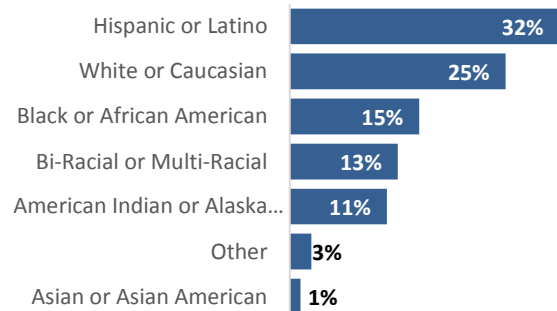
Most of the victims served were female



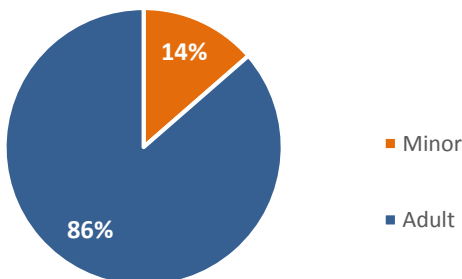
Most of the victims served were U.S. Citizens



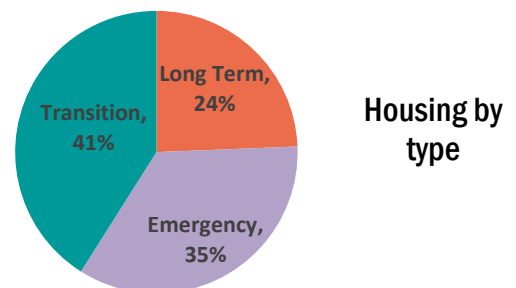
Most of the victims were Hispanic/Latino

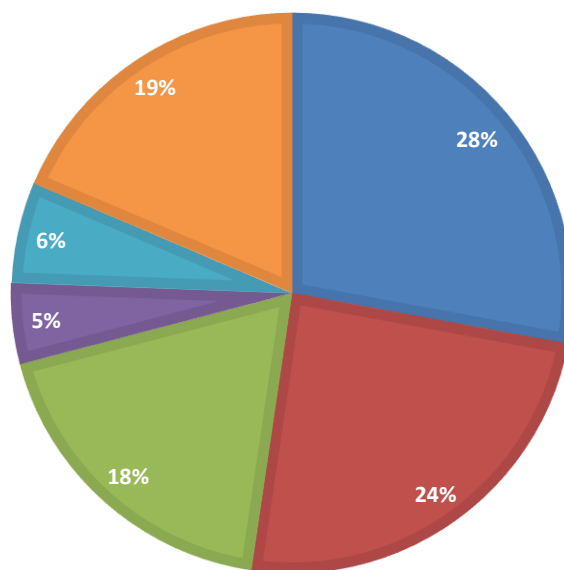
