Purpose

Provide a permanent system for independent and objective monitoring of children placed in the custody of the CYFD by examining the policies, procedures and practices of CYFD and, where appropriate, specific cases to evaluate the extent to which CYFD is effectively discharging its child protection responsibilities.



Meet the requirement of CAPTA to establish volunteer citizen panels to examine policies, procedures and practices to evaluate how state and local child protection systems are effectively discharging their child protection responsibilities and are in compliance with the CAPTA state plan, child protection standards and any other criteria considered important.



Provide public outreach to assess the impact of current procedures and practices upon children and families in the community.

Citizen Participation

- Federal and New Mexico state legislation require citizen involvement.
- Citizen participation is important because it:
 - Educates citizens regarding child protection system responses;
 - Promotes community-based services;
 and
 - Prevents an agency from becoming a 'system unto itself'.
- In New Mexico, citizens who meet eligibility requirements are known as SCAC Members.

Case Reviews

- At least one 'case' reviewed per Judicial District each FY Quarter. A case may include one or more children/youth.
- FY 20: Council adopted the Quality Services Review (QSR) Model for case reviews.
- Review:
 - Policy & Procedures;
 - Best Practices;
 - Documents;
 - Individual Input (confidential): legal representation, youth, service providers, CASA.
- Per the Act, for every child/youth reviewed a written report is provided to the court (presiding judge and all known Interested Parties). Standard report format, typically 4 pages.

- Case-based review process which:
 - examines delivery of services;
 - adherence to practice expectations;
 - provides a framework for talking about practice;
 and,
 - creates opportunities for shared problem solving.
- Utilized in some form in 20 states, including Washington D.C.
- 'The rigorous QSR process is an integral part of continuous quality improvement efforts and should be used to inform system practice changes'.

Required by CAPTA within 6 months of submission of report.

CYFD Response

Address recommendations.

Concern

Council Functionality

- No requirement of response to recommendations in court report;
- CYFD response to the annual report is 6 months and has not met federal standards;
- Sharing of information;
- Ongoing dialogue with CYFD for systemic improvement;
- Funding stability from interagency transfer of funds from CYFD.

Recommendations

Statutory Changes to Improve Council Functionality

- Clarify purpose.
- Administratively attach Council to Office of State Auditor.
- Expand the composition of the Council from 9 to 11 members and designate voting rights of members.
- Remove limitation on citizen eligibility to participate in Council activities.
- Replace the 6-member advisory committee with workgroups comprised of eligible citizens and other stakeholders.
- Provide periodic reports in addition to the annual report.
- Require CYFD to provide written responses and meet within a designed timeframe to reconcile differences.
- Include sections on access to, and confidentiality of, information.
- Reinstate line-item in HB 2 for state general funds appropriation and specify an interagency of transfer of funds from CYFD.

FY 20 Annual Report Recommendations CYFD

- Establish a workgroup to revise standard reports to the court; members of the workgroup should at a minimum include representatives of Council Staff, CYFD Quality Assurance Unit, CYFD direct staff, youth and legal representatives.
- In collaboration with the Public Education Department, co-lead a workgroup to develop protocols to ensure changes in school settings meet state and federal requirements.
- Review data reporting to ensure data provided is accurate.
- In collaboration with Council Staff, update policy and procedure regarding the Council.
