RECENT FEDERAL BROADBAND FUNDING

CARES Act Funding:

- \$25 million for the Distance Learning and Telemedicine grant program to prevent, prepare for, and respond to coronavirus for telemedicine and distance learning services in rural areas
- \$100 million for additional grants under the Rural Utilities Service Broadband Deployment Pilot Program (ReConnect)
- \$200 million for the COVID-19 Telehealth Program to support efforts of health care providers to address COVID-19 by using telehealth to connect with patients; Connected Care Pilot Program
- \$30.75 billion to the Education Stabilization Fund


Rural Digital Opportunity Fund, which will make available \$20.4 billion for rural broadband deployment
