Agency Updates

Annual Board Meeting

- 2019 Plan Changes
 - Pre-Medicare Plan Rates: 8% increase
 - Medicare Supplement : 6% increase
 - BCBS Premier Plan PPO Plan 3rd Tier Coverage
 - Presbyterian Bundled Payment Agreement
 - All Self Insured Plans Brand Drug Increase
 - Addition of SaveOn Program
 - Addition of Naturally Slim Program
 - Pilot Project for Secondary Expert Reviews
- Other Changes
 - Medicare Advantage: (-2.1% / -35.8% decrease)
 - Dental Plan Rate Increase: 3.9% 5.8% increase
 - Continued phase-out of Basic Life Insurance Coverage (50 percent)

Agency Updates Continued

Solvency 2017

- Deficit Spending 2020 (\$9.1 million)
- Projected Year of Insolvency 2035 (\$132.6 million)

Solvency 2018

- Deficit Spending 2022 (\$15.3 million)
- Projected Year of Insolvency 2037 (\$39.2 million)

Summary

- Deficit spending/solvency period extended 2 years
- \$92 million solvency ending difference

- NMRHCA adheres to the rules and regulations set forth in the New Mexico

- NMRHCA's goal is to ensure its members have the most accurate information about their health care as possible and how the agency operates to meet the needs and expectations of its members.

Transparency – Open Meetings

- NMRHCA adheres to Open Meetings Act rules requiring a public body to make the agenda of a regular or special meeting available to the public at least 72 hours in advance of the meeting and post meeting agendas on the NMRHCA.org website.
- NMRHCA announces all meetings at least 10 days in advance of the meeting, posting notices in its Albuquerque and Santa Fe offices and on its website.
- NMRHCA periodically holds meetings outside Albuquerque its two-day Annual Board Meeting in July travels to different cities in the state — to allow citizens around the state to attend in person.
- The agency encourages its members of the opportunity to attend public meetings at its educational seminars.
