The following demographics reflect our diverse population:

San Juan County has a population of 120,418 people with a median household income of \$47,485. The population is 37% White, non-Hispanic; 38% American Indian, and 15% Hispanic.33% of households speak a language other than English.

McKinley County has a population of 69,380 with a median household income of \$45,636. 74% of the population is American Indian, 15% is Hispanic, and 8% is White. 55% of households speak a language other than English.

SCRIBING

Keeping in line with our goal to provide access to justice for all community members, the Eleventh Judicial District Courts now offer scribing services to those in our community who need them. Scribing offers assistance with reading and writing to complete court forms for those with limited proficiency.

Many members of our community have limited hours in which to do business. By not remaining open during the noon hour, we restrict access to justice that many people may need. Effective September 1, 2023, all District Courts in the Eleventh Judicial District are open 8AM-5PM, with plans to expand those hours even more in the future.
