INTERIM SUMMARY

Federal Funding Stabilization Subcommittee 2025 Interim Summary

The Federal Funding Stabilization Subcommittee met six times during the 2025 interim across New Mexico to examine how federal funding changes affect the state's budget, programs and local communities. The subcommittee's work focused on understanding New Mexico's exposure to federal fiscal and policy shifts, assessing near- and medium-term risks and improving legislative readiness for potential disruptions. Early meetings established a baseline understanding of the role federal funds play in state budget and operations.

Health care, public benefits and education were recurring areas of analysis throughout the interim. The subcommittee reviewed pressures on Medicaid administration and financing and the outlook for health insurance coverage, hospital operations and rural access to health care. The subcommittee also examined federal funding for public schools, higher education and research, including how changes to grants and federal policy could affect institutions statewide. The subcommittee considered broader fiscal and tax implications of federal budget reconciliation actions, including potential effects on state revenue, tax administration and long-term budget stability, alongside updates on consensus revenue forecasts and the state's medium-term outlook.

The subcommittee also examined intergovernmental and regional dimensions of federal funding changes. Tribal leaders and state agencies discussed impacts on tribal governments and service delivery, while local government representatives described fiscal and operational challenges tied to federal uncertainty. Meetings in southern New Mexico focused on border-region dynamics, including commerce, transportation, agriculture and the effects of federal actions on cross-border supply chains. The subcommittee also heard from nonprofit and community-based organizations on service demand, operational strain and opportunities to strengthen coordination with state and local governments. The interim concluded with a review of findings, a discussion of emergency response and shutdown preparedness and the identification of priority areas for continued monitoring as federal fiscal conditions evolve.

Work Plan

The New Mexico Legislative Council created the Federal Funding Stabilization Subcommittee on April 28, 2025 to "create an inventory of federal funds flowing into New Mexico and provide recommendations with regard to recurring and non-recurring funds".

During the 2025 interim, the subcommittee will review and discuss the following topics, as time permits:

- A. review how federal funds have historically fit into New Mexico's budget and how those funds are currently appropriated;
- B. identify the amounts, timing and structure of major recurring federal funding streams, such as Medicaid and Title 1 education grants;
- C. assess the impact of and risk to large one-time appropriations such as those in the federal American Rescue Plan Act of 2021; Infrastructure Investment and Jobs Act, also known as the Bipartisan Infrastructure Law; Inflation Reduction Act of 2022; and CHIPS and Science Act of 2022;
- D. monitor federal actions, including executive orders, rulemaking and grant allocations, that could impact the distribution of previously approved or budgeted federal funding;
- E. receive updates on state-federal litigation with implications for New Mexico's federal funding;
- F. follow the progress of federal budget bills currently moving through the United States House of Representatives, United States Senate, congressional conference committee and signing process; and

- G. drill down on special high-impact areas such as ports of entry and Borderplex region projects, research funding from the National Institutes of Health and National Science Foundation and the Federal Highway Administration apportionment formula and discretionary grants for transportation infrastructure.

Wednesday, May 28

Welcome and Introductions (9:03 a.m.)

Representative Lundstrom welcomed everyone and subcommittee members introduced themselves.

Federal Funds in New Mexico's State Budget and Public Schools (9:10 a.m.)

Wayne Propst, secretary, Department of Finance and Administration; Charles Sallee, director, Legislative Finance Committee (LFC); and John Sena, director, Legislative Education Study Committee, participated in a panel on the impact of the changes in federal funds on the state's budget and public schools. Mr. Propst discussed the amount of federal dollars that went toward the state's budget and considered the state's reliance on federal dollars in the provision of services to New Mexico residents. He highlighted the numerous state employment positions funded by federal funds. Mr. Propst then briefly discussed the impacts of the 2025 federal budget reconciliation on public benefits programs, focusing on significant cuts in the federal Supplemental Nutrition Assistance Program and on Medicaid. He mentioned the importance of strengthening information sharing in state government and focusing on gaps in funding. Representative Lundstrom asked Mr. Propst to inform the subcommittee throughout the interim of any litigation to which the state is a party that develops in light of changes in federal funding.

Mr. Sallee focused on federal funding revenue in state agencies and the need for the subcommittee to focus on the cancellation of federally funded grants and programs. He encouraged the subcommittee to prioritize funding with General Fund dollars the programs that provide the most output to the state. Mr. Sallee then asked Eric Chenier, principal analyst, LFC, to briefly inform the subcommittee of where federal dollars can be seen in the state's budget. Following this, Mr. Sena focused his discussion on federal funding reduction impacts on K-12 education and how the LFC is tracking the changes in those funds. Mr. Sallee highlighted the impact in the changes in administration of federal funds and considered strategies for the state to fill in gaps in federal funding. Medicaid and Federal Supplemental Nutrition Assistance Program Financing 101 (11:03 a.m.)

Mr. Chenier and Allegra Hernandez, senior fiscal analyst, LFC, provided a presentation on funding for Medicaid and the federal Supplemental Nutrition Assistance Program. Mr. Chenier provided a broad overview of Medicaid and the number of enrollees in the state and state expenditures on Medicaid. He highlighted that about 80% of Medicaid spending is funded by federal funds and also highlighted the growth in state Medicaid spending. Ms. Hernandez focused on the Health Care Delivery and Access Act, which will infuse \$1.3 billion into state hospitals. Mr. Chenier then spoke about the proposed federal changes to the federal Supplemental Nutrition Assistance Program, specifically the requirement for states to match payments. Currently, the federal government pays 100% of Supplemental Nutrition Assistance

Program benefits and 50% of the administration costs. A full list of the changes can be found in the slides linked below. The presentation materials can be found here:

Overview of Federal Budget and Reconciliation Status (1:01 p.m.)

Mr. Sallee provided a presentation regarding the federal budget generally and the 2025 federal budget reconciliation and what it means for New Mexico's budget. Mr. Sallee highlighted the \$1.9 billion federal budget deficit for fiscal year 2024 and the difficult task of balancing that budget. Mr. Sallee then discussed the budget reconciliation process, which allows the federal government to align spending, revenue and the debt limit with agreed upon targets, and the federal congressional instructions for increasing federal debts for the 2025 federal budget reconciliation. Finally, Mr. Sallee emphasized that the 2025 federal budget reconciliation would greatly impact New Mexico's finances, with the largest risk being cost-shifting of federal Supplemental Nutrition Assistance Program benefits and administrative costs to the state.
