# Economy & Finance

County's taxable Taos receipts in gross construction grew by \$15 million, or 5 percent from this time last year. Construction is still the largest industry of the county's taxable gross receipts. making 26 percent of total taxable gross receipts, followed by retail trade at 25 percent.

- Taos County's unassigned general fund balance grew by \$5.9 million, or 564 percent, from FY21 to FY24. Unassigned fund balance represents money that has not been assigned to other funds and that has not been restricted, committed, or assigned to specific purposes within the general fund.
- Following its FY24, the county had six audit findings: three significant deficiencies, two noncompliance findings, and one other matter finding, all of which are repeated findings. Significant deficiencies include a lack of internal review.
- Taos County residents are paying less in property taxes in relation to their property value than the New Mexico average. The main driver of this is special levies, which constituents vote on. Voted special levies include levied property taxes towards hospitals, public schools, local colleges, etc.

\*Following the Office of the State Auditor's FY24 audit. the Town of Taos did not have any major audit findings.

## Town of Taos General Fund Balance (in thousands)



The Town of Taos's general fund has a high unassigned general fund balance. The town's general fund revenue increased by \$5.8 million, or 45.3 percent, over FY23, largely due to increases in gross receipts tax. The town also received a 56 percent increase, or \$311.4 thousand, from the cannabis excise tax in FY24 as compared to FY23.
