Economy & Finance

Lincoln County's taxable gross receipts in construction grew by \$11 million, or 33 percent from this time last year. Retail trade is still the largest industry of the county's taxable gross receipts, making 24 percent of total taxable gross receipts, followed by construction at 22 percent.

- Lincoln County's general fund is primarily made of unassigned funds. Unassigned fund balance represents money that has not been assigned to other funds and that has not been restricted, committed, or assigned to specific purposes within the general fund. Lincoln County has been receiving increases in state operating grants like law enforcement protection and enhanced 911.
- Lincoln County residents are paying less in property tax in relation to their property value than the New Mexico average. The main driver of this is special levies, which constituents vote on. Voted special levies include levied property tax towards hospitals, public schools, local colleges, etc.

Economy & Finance

*Following the Office of the State Auditor's FY23 audit, the Village of Ruidoso had 2 significant deficiencies and 1 noncompliance finding, including falsification of timesheets in the Police Department.

Village of Ruidoso General Fund Balance (in thousands)



The Village of Ruidoso had two deficits in unassigned fund balances in FY22 and FY23 not shown in the graph. The Village's deficits are caused by grant-funded projects. The Village expended its own funds for grants, which were not incurred in FY22 or FY23. The Village of Ruidoso has received increases in special revenues, including fire protection and law enforcement retention.
