Program Successes

Recent Highlights Include:

- Opened the first phase of the Taylor Mesilla Historic Site, the Reynolds Visitor Center, to the public
- Produced Voces de Latinidad, a documentary showcasing the richness of Hispanic identity in New Mexico
- Opened Weaving Meaning: Telephone Wire Art from South Africa, the first major North American exhibit of this unique art form
- Hosted Rio Grande Sky Fiesta at Los Luceros Historic Site with the Northern Rio Grande National Heritage Area
- Celebrated the reopening of the fully renovated Palace of the Governors with new exhibits
- Unveiled a tile mural featuring designs by 1,276 students who visited Bosque Redondo Memorial at Ft. Sumner Historic Site
- Launched a groundbreaking gallery at the Museum of Indian Arts & Culture, the JoAnn and Bob Balzer Native Market & Contemporary Art Gallery
- Continued the most significant capital investment since the New Deal era at Ft. Stanton Historic Site, including opening the renovated Nurses Quarters
- Awarded \$1 million in preservation grants through the new statewide Cultural Properties Restoration Fund
- Presented free Artist INC Express career development program in Gallup with gallupARTS
- Inaugurated the annual statewide Ekphrastic Poetry Contest
- Opened a new outdoor education space, the Diane Schuler Education Pavilion, at Coronado Historic Site
- Received AAM Reaccreditation at the NM Museum of Natural History & Science

Operational Success

- General Fund reversion of less than 0.01%
- No transfers out of 200s
- Created, advertised and filled 6 new FTEs funded in prior session
- Expended \$18.1 million in capital outlay
- Welcomed over 2 million visitors
- Served 685,000 children
- Filled 138 positions, including 23 promotions-a 17% promotion rate
- Purchased new Wonders on Wheels exhibition RV
- Purchased new Rural Bookmobile
- Invested over \$427,000 in NMCRIS upgrades
- Leveraged over \$1 million in Federal funds for online access to digital archives statewide
- Leveraged \$900,000 in FEMA funds for fire mitigation at Bosque Redondo, Ft. Stanton, and Los Luceros
- Water system improvements at Ft. Stanton resulted in 2 pt improvement in ISO rating for Ft. Stanton, increasing funding to local fire department, while lowering home and business insurance rates
- Received archaeological contracts with NMDOT, NMDGF, SLO and Pueblo of Acoma

Increase Funded Vacancy Rate

- Midyear FY24 12.5% vacancy rate, or -3% funded vacancy rate
- Increased hiring/reduced turnover, 375 FTEs vs 466 FTEs from January 2022 to January 2024
- Projected \$1.6 million deficit
- Immediately slowed hiring
- Evaluated and adjusted use of TEMP employees
- Adjusted labour rates charged to renters
- Increased review of overtime requests
- Ensured other funding sources were leveraged, e.g. federal funds, special appropriations, etc.
- Problem persists into FY25
- Exploring non-resident admissions increase
- Further restrictions in hiring
- An increase in the funded vacancy rate will allow for stabilization of vacancy rate while maintaining current level of services

NAGPRA \$5 million

Compliance with new requirements and timelines to this Federal law.



Marketing \$1 million

One-time investment in creation of marketing assets for museums and historic sites to grow visitation.



250th Commission \$500,000

Resources to implement the semi-quincentennial commission recommendations.



Rural Library \$10 million

NAGPRA

Native American Graves Protection and Repatriation Act

- Federal law requires cultural institutions to repatriate or transfer Native American human remains and associated cultural items to appropriate tribes
- Achieved through consultation, evaluation of requests for repatriation or claims for disposition, and providing public notice prior to disposition or repatriation
- Museums are subject to civil penalty by the US Department of the Interior for each instance of failure to comply
- Seven steps required: Compile a summary of holdings; initiate consultation; consult; receive and consider requests for repatriation; respond to request for repatriation; submit notice of intended repatriation; repatriate items
- New deadlines were implemented in January 2024
- Most museums are faced with one-time or limited compliance
- Archaeological Research Collections of the Museum of Indian Arts & Culture is the State and Federal repository in New Mexico, creating an ongoing cycle of compliance
- Request is for two years of special funding to support: expert consultation to create practices, procedures and policies; temporary staff to conduct object-by-object review of all holdings; and funding for tribal consultations
