District Judge & Staff – Family Division \$468.1 Judge; TCAA & Court Monitor There are 4 judges and 8 hearing officers (2 of which are funded by Child Support Services Division (CSSD) in the Family Division. Hearing officers primarily hear domestic violence and child support cases, and on a limited basis may hear other family court matters. The judges hear divorce, kinship guardianship, custody/visitation, parentage, emergency firearm protection order (ERFPO) hearings, and special immigrant juvenile cases. Many of those case types require hearings within ten days of filing and most cases have pro se litigants. In addition, the judges are on call 24 hours a day, 7 days a week for receiving and processing all emergency domestic violence orders from law enforcement officers. Judges must be available to address emergency issues in all domestic matters' cases, including violations of DV orders, and must supervise and review all work completed by hearing officers. In FY24, there were a total of 9,665 new and reopened family court cases. Of those, 5,039 were divorce, kinship guardianship, custody/visitation, parentage, ERFPO, and special immigrant juvenile cases; 4,626 were DV and child support cases. This is an average of 1,260 cases per judge.
