FY26 Budget Request



The request reflects a 6.1% overall increase including an additional \$37.8 million of General Fund which includes funding for:

- 101 positions to meet the Kevin S. settlement caseload standards
- Facilities to reduce office stays
- CYFD Training Academy
- Cultural activities for children in care
- General Fund swap to replace \$13.0 Million of Federal funds in the Protective Services program
- Increase to GSD and DoIT rates
