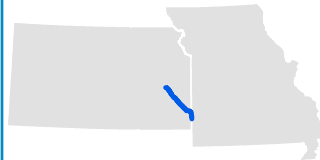
Crossroads-Hobbs-Roadrunner

Wolf Creek-Blackberry



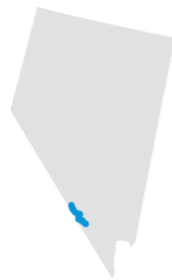
~92-mile 345 kV single circuit transmission line – spanned 3 counties with interconnection to 3 OG&E-owned substations. Met SPP's need date with project costs at the proposed cap level

Minco-Pleasant Valley-Draper



~50 miles of 345 kV transmission line strengthening grid **reliability and reducing congestion** in Central Oklahoma. **Constructed in under 2.6 years.**

GridLiance West Upgrades



~220 miles of 500 kV and 230 kV transmission lines enabling **economic development** in Southern Nevada

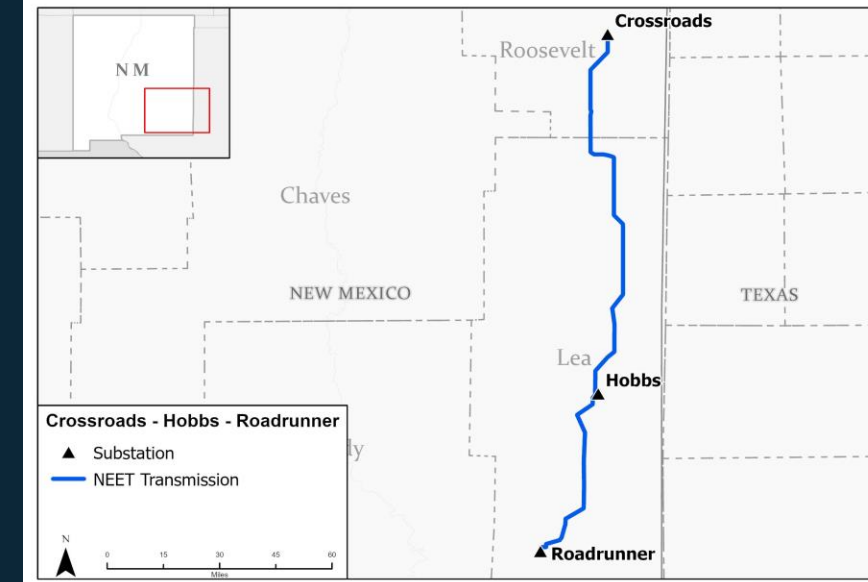
