#### Inmate Health Contracts

- Centurion (Medical) Contract \$42.6 million
  - Covers all medical care for inmates in state and private facilities, with the exclusion of Otero County
- MHM (Behavioral Health) Contract \$2.2 million
  - Provides behavioral health care alongside state employees at Western New Mexico Correctional Center and Springer Correctional Center
- Boswell (Pharmacy) \$11 Million Cap
  - FY 17 spent \$7.25 million

# Hepatitis C Summary

- Collaboration with UNM Project ECHO
- Total inmates that have completed the treatment: 95
- Inmates currently receiving Hep-C treatment: 8
- 98% cleared with no viral load detected
- Total spent to date \$8 million

# Project ECHO Partnership

- NMCD established partnership with Project Echo to assess and treat inmates diagnosed with Hepatitis-C.
- NMCD and Project Echo has expanded their partnership to include effective treatment of our HIV population.

#### Inmate Initiatives

- Diabetes Wellness Program
  - An ongoing wellness education intiative
  - Inmates are educated on the importance of proper diet and exercise
- Lactation Pilot
  - Inmates will be able to express breast milk while incarcerated.
  - Working with advocacy groups for supplies, such as pumps, storage bags, etc.
- Sober Living Communities
  - Use of inmate mentors to increase program accountability and continuation of treatment.

#### Naloxone

- Naloxone provided upon discharge
- Educated by both Medical and Behavioral Health
- Approved overdose education on:
  - Causes of an Opioid Overdose
  - Recognition of an Overdose
  - Administration of Life Saving Techniques
  - Administration of Naloxone
  - How to Contact Emergency Services

#### Behavioral Health Services

#### Over 90% of our programming is evidence-based

- Personal Hygiene Psycho-educational Groups
- Healing Trauma
- DWI Groups
- Anger Management Groups
- Self-Esteem for Challenged Inmates Groups
- Social Skills for Challenged Inmates Groups
- Grief Support
- Use of various therapeutic modalities, such as Dialectical Behavioral Therapy (DBT); Cognitive Behavioral Therapy (CBT); and Trauma Informed.

#### Mental Health Treatment Center

- Inpatient Psychiatric Hospitalization
- Male MHTC (104 beds)
  - 20 Acute care beds
  - 20 Stabilization Beds
  - 64 Chronic Care Beds
    - 16 of those are part of a Therapy Dog Program
- Female MHTC (18 Beds)
  - 2 Acute Care Beds
  - 16 Continuing Care Beds

# Residential Drug Abuse Program

- NMCD offers several evidence-based substance abuse programs.
- Provided in an residential living environment
- Curriculum includes components of:
  - Substance abuse
  - Criminal Thinking
  - Trauma Healing
  - Triggers
  - Anger
  - Self-care
- Last year, RDAP at NMCD showed a 10% recidivism which is below the National standard.

### Other Substance Abuse Programming

- Intensive Outpatient Treatment
  - 100 Hours (3 -4 month)
  - Three days a week, three hours a day
- DWI program
  - 40 hour program
  - Provides offenders with education regarding the effects of DWI
  - Cognitive and Psycho-educational in nature

## Healthcare Services Oversight

- Contract in place with HealthInsight to provide nurse auditors for RN expertise in compliance reviews.
- Plan for direct hire of a Clinical Nurse/Auditor.
- Hiring a second internal compliance officer.
