Education Efforts to Preserve Native American Language

Bilingual Multicultural Education Annual Report

- The Bilingual Multicultural Education Act, Section 22-23-1 NMSA 1978, requires each school district and charter school to annually report academic achievement and language proficiency data to the Public Education Department (PED). Statute requires PED to annually compile and report the findings to the Legislature.
- PED has made the bilingual multicultural annual reports publically available for the 2012-2013 school year through the 2019-2020 school year.
- The most current report was published by PED in 2021, using data from the 2019-2020 school year. See <u>Tab A</u>.

Tribal Education Status Report

- The Indian Education Act, Section 22-23A-1 NMSA 1978, requires PED to publish an annual statewide tribal education status report. School districts and charter schools that serve significant populations of Native American students are required to publish tribal education status reports.
- PED has made the statewide tribal education status reports publicly available for the 2005-2006 school year through the 2019-2020 school year.
- Tribal status reports are publically available on PED's website for the following school years: 2017-2018, 2018-2019, and 2019-2020.
- The most current tribal education status report was published by PED in November 2020 for the 2019-2020 school year. See <u>Tab B.</u>
