EDD BUDGET & STAFFING: PAST & PRESENT

- FYI0: 70 FTE (agency peak)
- FY20: 52 FTE
- FY10 recurring general fund budget*: \$7.9 million

\$9.4 million in FY20 dollars after inflation

- FY20 recurring general fund budget*: \$8.1 million
 - \$6.8 million excluding other new non-operational budget expenditures
- *Budget for operations excludes funding for JTIP and the NM Partnership

- Increase FTEs from 52 to 58 still 12 fewer than a decade ago
- Fund Outdoor Recreation Division
- Fund essential staffing to fulfill program functions, ensure accountability & improve data tracking/reporting

PROGRAM SUPPORT REQUEST

Fund 4 FTE (\$288,600)

- Fund 2 unfunded vacancies: second economist & attorney
 - Needed to maintain timely and accurate analyses and legal documents related to LEDA and other projects
 - Will improve tracking, reporting and analysis
- Fund 2 new FTE: grant writers to compete for millions of dollars in federal grants
 - Many millions bypass New Mexico each year because we do not have staff time for lengthy grant applications
 - The small general fund amount can leverage federal funds many times over



OUTDOOR RECREATION REQUEST

- Fund 2 new FTE and marketing and advertising (\$989,000)
- New division created in 2019 session but with only \$200,000 in operating funding and \$100,000 "junior bill" money for the outdoor equity fund
- Additional funding is necessary to allow this division to succeed \$200,000 is not enough to staff and advertise the program
- Hiring the best people for the two positions with outdoor recreation marketing and economic development experience results in combined salary and benefits of more than \$200,000
 - We can manage for FY20 with some budget savings in the Economic Development Division, but funding is insufficient for FY21
 - An increase is needed just to fund these 2 FTE and provide for necessary travel and events, but if we want New Mexico to become a premier destination for outdoor recreation travel, events and businesses, we need a significant increase



FILM DIVISION REQUEST

- Fund 2 new FTE (\$118,800)
 - Need to handle increased film credit program and production activity
 - Significant improvements in data tracking and reporting, but this takes more staff time
 - To ensure high quality data tracking and reporting for this rapidly expanding industry and recently expanded credit, we need more staffing
- Fund essential website updates, marketing events and the annual film & media conference (\$168,400)
 - Film & media conference receives nearly 3,500 attendees
 - Marketing events allow the Film Division to educate more businesses on industry resources in the state, including facilities and support businesses in rural locations



ECONOMIC DEVELOPMENT DIVISION REQUEST

- Fund I unfunded vacancy and two leased vehicles necessary for the Community, Business & Rural Development Team (CBRDT) (\$101,000)
- Over time, as local government budgets have been crunched, there have been fewer full-time local economic developers with fewer resources
- Our CBRDT "regional reps" fill a critical role by supporting economic development activities across the state, providing "boots on the ground" when local governments cannot afford to do so and by coordinating with local economic developers
 - Working to improve internal performance measures to gauge these impacts



JTIP SPECIAL APPROPRIATION REQUEST

- Demand for the program is increasing – 70 businesses assisted in FY19 – 2,333 workers trained
- Appropriations have not kept pace with demand
- FY20 target is 2,050 trainees
- The Math: 2,050 trainees

FY20 Performance Targets:

- Number of jobs created through the use of LEDA funds = 2,500
- Number of private sector dollars leveraged by each dollar through LEDA = 12:1



LEDA SPECIAL APPROPRIATION REQUESTS

Funding Request: \$40M

- \$30 million to bring available balance back to \$75 million at the end of FY20
 - Conservatively estimated projects likely to close within 8 months
- \$10 million for rural infrastructure projects
 - This would be a new LEDA policy track to give greater flexibility for rural projects
 - Addresses one of the two top issues noted by site selectors & executives: infrastructure and education
 - Gives our rural communities a chance to fight for projects with shovel-ready sites
- Requesting extension of prior LEDA appropriations

LEDA Balance in SHARE: \$67.8 million

LEDA Available Balance: \$52.8 million

LEDA Pipeline: \$105 million

FY19 LEDA Impact:

- 2,891 jobs
- \$1.2 billion new private investment
- 8 rural projects 970 jobs



CERTIFIED SITE PROGRAM SPECIAL APPROPRIATION REQUEST

One-Time Request of \$5 Million

The New Mexico Certified Sites Program will provide matching funds to communities and private businesses to assist with the costs of achieving a certified site

- Certified sites demonstrate construction readiness, enhancing marketability
- Typical requirements for certification include utilities on site, surveyed & platted, completion of any required environmental studies and a commitment to sell for an agreed upon price
- Certified sites are most impactful in small, rural communities



TECHNOLOGY RESEARCH COLLABORATIVE (TRC) SPECIAL APPROPRIATION REQUEST

\$10 Million

- For competitive grants approved by the Technology Research Collaborative to assist high technology businesses in the state and facilitate technology transfer from the public sector to the private sector within the state
- Current budget amount is \$100,000
- Will allow for matching grants to tech startups

SPECIAL APPROPRIATION REQUEST TO FUND THE DEVELOPMENT OF A 20-YEAR COMPREHENSIVE STATEWIDE PLAN

One-Time Request of \$300 Thousand

- Develop a 20-year, comprehensive, statewide economic development plan that addresses the need to diversify the state's economy with regional plans to help all communities
- \$300,000 will be used to hire professional experts to review strengths and weaknesses of regions of the state and help develop a 20-year strategy
- A true statewide plan will include input from various agencies and stakeholders at the state and local levels and act as a plan for all these stakeholders, not just EDD, so the plan will have staying power across administrations – like the "NM True" branding



SPECIAL APPROPRIATION REQUEST TO EXTEND THE HOURS AT SANTA TERESA POE

One-Time Request of \$450 Thousand

 \$450 thousand for a memorandum of understanding with U.S. Customs & Border
Protection to extend the hours of operation at the Santa Teresa POE
