




# NM County Detention Facilities' Design Bed Capacity & Accreditation Status






### Detention Bookings 2018-2022

- Much Smaller Study Group (COVID)
- Length of Stay has increased
- More Detainees are Charged with a Felony
  - 90% charged with Felony
  - 21% on Probation Violation
  - 52% charged with violent offense







### San Juan FY2022 Per Diem Received



### Dona Ana County Bookings by Arresting Agency 2015-2020


### Dona Ana % of Bookings 2015-2020



# Bernalillo County Bookings by Arresting Agency 2010-2022


### Bernalillo County % Of Bookings 2010 - 2022




### FY2022 Total County Jail Costs
