## Community Governance Attorney Act Program (SB 244)

- Legislation enacted in the 2019 Legislative session
- ➤ Established Community Governance Attorney Act Program
  - Tuition waiver for up to 2 3<sup>rd</sup> year UNM Law Students
  - Tuition forgiven if students provide 2 years of pro-bono legal work to benefit land grants, acequias, colonias
- ➤ Established fund that would pay for up to 50% of CGA attorney positions for providing pro-bono legal services
- Established CGA Commission to select students, NGOs
  - Commission staffed by UNM Law
- HED lead implementing agency

# Funding was not Successfully Appropriated into CGA Fund

- CGA Act established non-reverting fund for the program, including for NGO positions
- 2019 legislature appropriated funds, but final language did not specify CGA Fund
  - > \$50,000 to "establish" CGA program
  - > \$200,000 to "to provide legal services for land grants-mercedes, acequias and indigent persons in colonias"
  - ➤ DFA ruled that funds could not be deposited in CGA Fund, and would revert at the end of July 2020
- ➤ In 2020, HED requested funds that would fund first two CGA attorneys.
  - Legislature did not appropriate funding in the budget
- Without CGA funds, the CGA attorney positions are not funded

## Next Steps

### **Commission:**

- Utton Center received \$5,000 to staff the Commission
- Will be reaching out to Commissioners to host first public meeting in September, October
- Commission will need to develop rules, provide input on regulations

#### **HED:**

- Has worked with Law School to start drafting regulations
- Will need to develop regulations, model contracts for program

# Summer Community Governance Fellowships

- ➤ After discussion with stakeholders, HED decided to spend a portion of \$200,000 for legal service to fund summer fellows
- > 7 fellows worked with 3 organizations from May 18 to June 26 (6 weeks)
  - > 3 fellows at NM Acequia Association
  - > 2 fellows at NM Legal Aid
  - > 2 fellows at UNM School of Law NREL Clinic
- > Total funding \$42,187.50
- **➢** Overall, positive reviews from NGOs, Fellows
