



SWTAG: Subsidized Broadband

- Universal Services Administrative Corporation
- \$581M
- Up to 65% subsidy on broadband cost or eligible equipment
- Rural health care entities
- Consortia may be urban and rural providers, with a rural majority
- Rural health clinics, hospitals, skilled nursing, public health departments, FQHCs, community mental health centers, off site data centers and administrative locations
- SouthWest Telehealth Access Grid (SWTAG) is NMTA's USAC-approved consortium




NM SB354: Telehealth Payment

- Overcomes geographic, time, social and economic barriers to care delivery
- Key components:
 - Parity in coverage and reimbursement for services delivered via telemedicine or in-person
 - Eliminates distance barriers
 - Does not allow insurance companies to limited telemedicine to in-network providers
 - Prevents health plans from imposing annual or lifetime maximum for service coverage
 - Includes Remote Patient Monitoring (RPM)




SB 354: Health Coverage via Telemedicine



Health plans cover out-of-network telemedicine services where no innetwork provider is available and accessible, as defined under network adequacy standards issued by the Superintendent

- Health care professionals working within the scope of their professional license
- CMS reg relaxation also allows

Remote Patient Monitoring

- CMS reg relaxation waives HIPAA compliance in March 2020
- https://www.cms.gov/Medicare/Medicare-General-Information/Telehealth/Telehealth-Codes October 2020, CMS adds 11 new services, including certain cardiac rehab and monitoring services **NEW MEXICO** Telehealth Alliance

NM OSI and Medicaid authorized local plans to match CMS flexibility

Telemedicine in NM Today

No mechanism to track volume of telemedicine visits without an All Payor Claims Database

- OSI Director Toal reports all carriers paying smoothly*
- Anecdotal Physical Therapy sites say 10%
- BHSD & CYFD studying telemedicine under COVID for changes in no-show, cancellation, successful referrals, satisfaction



Federal Telemedicine Data: Medicaid and CHIP Beneficiaries

- 34,538,375 services delivered through telehealth from March through June 2020
- 2,632% more services delivered compared to March through June 2019
