



## **READINESS IMPACTS**



#### 111<sup>th</sup> SB

- + The 111th SB being the C2 for the JTF, BDE staff operations for real world DSCA emergency.
- Overall training plan for the year was significantly impacted (April drill cancelled, May and June were virtual drills. July drill was in-person, however attendance still impacted by COVID pandemic. Numerous schools cancelled or re-scheduled.

### 615th Trans BN

+ Soldiers of the Task Force have been able to exercise many tasks such as manage assigned and attached units providing transportation support, plan transportation operations, manage company motor transport operations, and provide motor transport support. However none of these tasks were able to be assessed due to the lack of leaders present. The Task Force operated under a very degraded state in respect to senior staff and NCO availability.

- The COVID-19 response caused the BN to lose 17 school reservations, 3 battle assemblies cancelled for the 720th TC, 1 battle assembly cancelled for the HHD and 1115th and two battle assemblies conducted virtually for the HHD and 1115th

#### 226<sup>th</sup> MP BN

+ Exercise BN staff operations for real world DSCA emergency, checkpoint and traffic control operations, area security ops, detainee ops training to support Detox center, show of force, and community relationship growth.

- Overall training plan for the year was significantly impacted (April drill cancelled, May and June were virtual drills). July drill was in-person, however attendance still impacted by COVID pandemic. Numerous schools cancelled or re-scheduled.

### G Co, MEDEVAC AVN

- + Increase in flight experience for crews assigned to COVID19.
- No in person drills prior to Aviation Resource Management Survey and deployment. NTC rotation cancelled.
