



## Fiscal Analyst - Capital Outlay

The Legislative Finance Committee is recruiting to fill **an analyst position on the capital outlay team focused on research and oversight**. We are recruiting motivated and talented professionals who are interested in public policy, budgeting, and improving government.

The LFC capital outlay team is responsible for reviewing capital project requests and developing funding recommendations to the Legislature for capital investment, conducting oversight of funded projects and infrastructure programs, and advising the Legislature on policy issues related to infrastructure planning, development and finance. The capital outlay team includes a principal analyst, a fiscal analyst for budget, and the research and oversight fiscal analyst. The research position straddles the LFC's budget and program evaluation work, with a specific focus on evaluating the state's infrastructure programs and the outcomes of capital spending. The analyst's work will include focused oversight of individual capital projects as well as deep-dive policy briefs on infrastructure programs or areas of need. The research the position produces contributes to the LFC's oversight mission and informs and improves capital budgeting and policy.

The analyst will work as part of the capital team but have a high degree of autonomy in carrying out assigned research projects and will have the opportunity to help shape the direction of oversight work. The work is intellectually demanding, time-sensitive, and closely considered by lawmakers. Successful candidates must have superior time, communication, and research skills, understand the policymaking environment, and be able to work effectively with legislators, executive branch staff and leadership, and local government stakeholders.

- Strong writing, oral communication, and critical thinking skills
- Familiarity with Microsoft products (Word, Excel, and PowerPoint)
